The President called the meeting to order at 6:20 PM.

### Minutes

Motion to approve 9/28/10 minutes by Mr. Mulligan; second by Mr. Edwards. The motion passed unanimously.  
Motion to approve 10/5/10 minutes by Mr. Mulligan; second by Mr. Edwards. The motion passed unanimously.

### Secretary-Treasurer Report

The secretary-treasurer reported that the CFOA has decided to partner with NASO. California Football Officials Association President Pat Bachus has called for a special meeting to revote on the partnership, however. If the partnership remains, dues for members of the California Basketball Officials Association (CBOA) will be \$90, and non-CBOA members' dues will be \$110. If the partnership is reversed, dues will remain at \$85 for everyone who pays by the banquet, and \$105 thereafter.

### Assignor Report

Mr. McQueen reported that there have been a lot of games with a "free 4<sup>th</sup> man" and that there are five paid games next week for new officials. All officials have been offered paid games. There have been three no-shows so far this year, two of which were first year officials.

Mr. Winkley asked Mr. McQueen what happened with the Marshall/Kilpatrick game. Mr. McQueen replied that Marshall changed the date of the game but did not inform him.

### Old Business

#### Runoff election

Steve Brink and Bob Branson were elected to member-at-large positions. There will be a runoff election for the remaining position between Raul Pardo, John Puncel, and Ruben Vega because no candidate received a majority vote. The banquet will be designated a "special meeting", and a runoff election will occur.

#### Banquet

The board discussed awards for the banquet. We will honor retiring officials Tommy Huitron and Dick Loggins, and will create the Joe Conte, Sr. Award that will be given annually to an official who has provided considerable service to the association. Mr. Conte will be the inaugural recipient. Position awards will be given to Steve Brink (Outstanding Back Judge), Alex Castro (Outstanding Umpire), Joe Pavlik (Outstanding Head Linesman), Tim Dow (Outstanding Line Judge), and Mario Miranda (Outstanding Referee). A Rookie of the Year award will also be given to a new official to be determined by his instructors, Joe Conte, Sr., and Mr. Dominguez. Mr. Winkley announced that Steve Strimling would be the guest speaker at the banquet.

#### CFOA/NASO Partnership

Concerning the CFOA/NASO partnership, the President asked what was best for the unit, and discussion ensued. Mr. Winkley motioned that we support the CFOA/NASO partnership unless unforeseen circumstances arise; second by Mr. Landinguin. The motion passed unanimously.
